What has been done since the meeting in Prague?

Following the transition-planning document many actions have been undertaken:

- In February the EFRS will be officially established in the Netherlands by a memorandum of association with a notary in Utrecht. For this purpose the constitution was translated in Dutch.
- The Board developed a policy document for the EFRS election procedures This document is sent out to all EFRS members for review and action together with this Newsletter.
- The board developed a policy document for the relation EFRS & ISRRT This document is sent out to all EFRS members for action together with this Newsletter.
- The bank account is established and operational for international payments.
- A simple book-keeping for income and expenses is set up and the results over the first 10 months will be presented in the AGM.
