## First EFRS Annual General Meeting (AGM)

As announced in EFRS News 1 the first EFRS Annual General Meeting will take place in Lisbon on Friday and Saturday the 7<sup>th</sup> and 8<sup>th</sup> of November 2008.

The meeting will start on Friday at 13.30 hrs. and will continue on Saturday the 8<sup>th</sup> all day. Saturday evening the event will be closed by a dinner/dance celebrating the first EFRS AGM and of course *Radiography Day*.

As soon as all arrangements and calculations are ready EFRS members will receive the registration form and the exact amount of the registration fee. The fee is approximately € 75,- per person. All travel and hotel arrangements are the responsibility of the participants. A list of suitable hotels will be provided with the registration form.

**Elections:** During the AGM the first Board and committees of the EFRS will be elected. To organize these elections the transitional Board will need the approval from the members of the team election system as proposed in Prague. A document with all needed information and the voting procedure is sent to all members with this EFRS News. The deadline for voting is open until the 30<sup>th</sup> of April.
